My participant status will be kept in good standing. I will not compromise myself in such a way as to do harm to the league or tournament, knowing that participants may be dismissed from participation, with possible loss of payment or dues, for violent conduct or unsportsmanlike behaviour on or off the court of play. I agree to pay for any and all damages to any property or indemnities caused by me willfully, negligently, or otherwise.

Basketball is a physical, contact, sport that involves the risk of injury. I assume all risks and hazards associated with my participation in the sport. I am in proper physical condition to participate in basketball practices and games and have no illness, disease or existing injury or physical defect that would be aggravated by my participation. I will inform my coach if this status changes. I further acknowledge that this risk may involve loss or damage to me or my property, including the risk of death, or other unforeseen consequences, including those which may be due to the unavailability of immediate emergency medical care. I have a current medical consent form in force. I will wear properly fitted and appropriate basketball shoes and team wear, as provided by YEBA rules, to all events. The tournament does not have personal injury insurance that covers my participation.

Therefore, I should have a current, active, personal injury insurance policy in force, which covers my participation. Under any condition, I am responsible for any and all medical expenses arising from my participation, both in practices and games and while travelling to and from the YEBA events.
